An Act of the Parliament of the Cook Islands to appropriate certain sums of money out of the Cook Islands Government Account to the services of the Financial year ending with the thirty-first day of March 1982 and to amend the Appropriation Act 1981 (17 March 1982)

MOST GRACIOUS SOVEREIGN - We, Your Majesty's most dutiful and loyal subjects, the Parliament of the Cook Islands towards making good the supply which we have cheerfully granted to Your Majesty in this year, have resolved to grant unto Your Majesty the sums hereinafter mentioned and do therefore most humbly beseech Your Majesty that it may be enacted; And be it enacted by the Parliament of the Cook Islands in Session assembled and by the authority of the same, as follows:

1. Short Title - This Act may be cited as the Appropriation Amendment Act 1981-82 and should be read together with and deemed part of the Appropriation Act 1981 (hereinafter referred to as "principal Act").
2. Grant and appropriation of \$15,426,800 out of the Cook Islands Government Account - Subsection (1) of section 2 of the principal Act is hereby amended by omitting the amount of \$15,536,900 and substituting the amount of \$15,426,800.
3. Schedule - The principal Act is hereby further amended by omitting the Schedule and substituting the following Schedule.
