EXECUTIVE AUTHORITY OF FIJI DECREE 2009 (DECREE NO. 2)

MINISTERIAL ASSIGNMENT

To: Mr Joketani Cokanasiga
Minister for Defence, National Security and Immigration

WHEREAS, in exercise of the powers vested in me as the President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), I appointed you as the Acting Minister for Defence, National Security and Immigration, with effect from 17 November 2010 and assigned to you the responsibility for the conduct of Government business and departments and the written laws specified in Legal Notice No. 13 of 2011;

AND WHEREAS, in exercise of the powers vested in me as President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), I revoked with effect from the 16th day of January, 2012, all assignments of responsibilities under Legal Notice No. 13 of 2011, and with effect from the same day assigned to you as the Minister for Defence, National Security and Immigration, the responsibility for the conduct of the Government business and departments and the written laws specified in Legal Notice No. 87 of 2012

NOW THEREFORE, in exercise of the powers vested in me as the President of the Republic of Fiji and Commander in Chief of the Republic of the Fiji Military Forces by the Executive Authority of Fiji Decree 2009 (Decree No. 2), I hereby revoke with effect from the 12th day of August, 2013, all assignments of responsibilities conferred upon you as specified in Legal Notice No. 87 of 2012, and with effect from the same day assign to you in as the Minister for Defence, National Security and Immigration, the responsibility for the conduct of the following Government business and departments and for the following written laws (subject to the provisions of any other laws)—
