LAGILAGI HOUSING DEVELOPMENT ACT 2022

Lagilagi Housing Development (Application) Regulations 2022

IN exercise of the powers conferred on me by sections 4 and 7 of the Lagilagi Housing Development Act 2022, I hereby make these Regulations—

Short title and commencement

1.—(1) These Regulations may be cited as the Lagilagi Housing Development (Application) Regulations 2022.

(2) These Regulations come into force on the date the Lagilagi Housing Development Act 2022 comes into force.
