## Land Transport (Prescribed Forms) (Amendment) Regulations 2018

In exercise of the powers conferred on me by section 113 of the Land Transport Act 1998, I hereby make these Regulations—

*Short title and commencement*

1.—(1) These Regulations may be cited as the Land Transport (Prescribed Forms) (Amendment) Regulations 2018.

(2) These Regulations are deemed to have come into force on 1 January 2018.

*Schedule amended*

2. The Schedule to the Land Transport (Prescribed Forms) Regulations 2000 is amended after Form 3 by inserting the following new form—
