Public Law No. 7 - 5 1

AN ACT

To further amend section 3 of Public Law No. 6-89, as amended by Public Law No. 7-7, Kosrae State public projects, to modify the allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 6-89, as amended by
2 Public Law No. 7-7, is hereby further amended to read as follows:
3 "Section 3. All funds appropriated by this act shall be
4 allotted, managed, administered, and accounted for in
5 accordance with applicable law, including, but not limited
6 to, the Financial Management Act of 1979. The allottee of
7 the funds appropriated under subsections (1) and (5),
8 except paragraph (a) of subsection (5), of section 2 of
9 this act, and paragraphs (3)(c), (3)(d), (3)(e), (3)(f),
10 (3)(g), (3)(h), (4)(b), (4)(d), (4)(e), (4)(f) and (4)(g) of
11 section 2 of this act shall be the Chairman of the KSCIP.
12 The allottee of the funds appropriated under paragraph (a)
13 of subsection (5) of section 2 of this act shall be the
14 Governor of Kosrae State. The allottee of the funds
15 appropriated under subsection (2) of section 2 of this act
16 shall be the Mayor of Lelu Municipality. The allottee of
17 the funds appropriated under paragraphs (3)(a) and (3)(b)
18 of section 2 of this act shall be the Mayor of Tafunsak
19 Municipality. The allottee of the funds appropriated under
20 paragraphs (4)(a) and (4)(c) of section 2 of this act shall
21 be the Mayor of Malem Municipality. The allottee of the
22 funds appropriated under subsection (6) of section 2 of

1 this act shall be the Chairman of the Kosrae Congressional
 2 Delegation. The allottees shall be responsible for
 3 ensuring that these funds, or so much thereof as may be
 4 necessary, are used solely for the purposes specified in
 5 this act, and that no obligations are incurred in excess of
 6 the sum appropriated. The authority of the allottees to
 7 obligate funds appropriated by this act shall not lapse
 8 until expended."

9 Section 2. This act shall become law upon approval by the
 10 President of the Federated States of Micronesia or upon its becoming
 11 law without such approval.
