

AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 1, as amended by Public Law No. 5-99, to modify the use of funds previously appropriated for statewide public projects in Chuuk State, by further amending section 2, as amended by Public Laws Nos. 5-99, 5-129, 7-2 and 7-60, to modify the use of funds previously appropriated for public projects in the Northern Namoneas region of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 5-89, as amended by Public Law  
2 No. 5-99, is hereby further amended to read as follows:

3 "Section 1. Statewide public projects. The sum of \$110,216, or  
4 so much thereof as may be necessary, is hereby appropriated  
5 from the General Fund of the Federated States of Micronesia for  
6 the fiscal year ending September 30, 1989, for the purpose of  
7 funding certain statewide public projects in Truk State. The sum  
8 appropriated by this section shall be apportioned as follows:



4                   Section 2. Section 2 of Public Law No. 5-89, as amended by Public Laws  
 5 Nos. 5-99, 5-129, 7-2 and 7-60, is hereby further amended to read as follows:

6                   "Section 2. Northern Namoneas public projects. The sum of  
 7 \$421,000, or so much thereof as may be necessary, is hereby  
 8 appropriated from the General Fund of the Federated States of  
 9 Micronesia for the fiscal year ending September 30, 1989, for the  
 10 purpose of funding certain public projects in Northern Namoneas,  
 11 Truk State. The sum appropriated by this section shall be  
 12 apportioned as follows:

- 14                   (a) For study outside of the Northern  
 15 Namoneas region.....\$ 5,500.00
- 16                   (b) For study by correspondence  
 17 course..... 2,000.00
