A BILL FOR AN ACT

To appropriate the sum of \$3,050,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the purpose of providing funding for social and economic development projects in each of the States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. The sum of \$3,050,000 or so much thereof as may be 2 necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1995, for the 3 purpose of providing funding for social and economic development projects in 4 5 each of the States. 3	Section 2. All funds appropriated by this act shall be allotted, managed,
4	administered, and accounted for in accordance with applicable law, including,
5	but not limited to, the Financial Management Act of 1979. The allottee of the
6	funds appropriated under subsection (1)(a) of section 1)(c) and (1)(d) of
7	section 1 of this act shall be the National Planner of the Office of Planning and
8	Statistics of the Federated States of Micronesia, or his designee. The allottee
9	of the funds appropriated by subsection (1)(b) of section 1 of this act shall be
10	the Southern Namoneas Authority. The allottee of the funds appropriated by
11	subsection (1)(e)(i) of section 1 of this act shall be the Hall Islands
12	Development Authority. The allottee of the funds appropriated by subsection
13	(1)(f) of section 1 of this act shall be the Executive Director of the Chuuk
14	Organization for Community Action." The allottee of the funds appropriated by
15	subsections (1)(2), (1)(4) and (1)(5) of this act shall be the President of the
16	Federated States of Micronesia, or the President's designee. The allottee of the
17	funds appropriated under section 1(3) shall be the Governor of the State of
18	Yap. The allottee shall be responsible for ensuring that these funds or so much
19	thereof as may be necessary, are used solely for the purpose specified in this
20	act, and that no obligations are incurred in excess of the sum appropriated.
21	The authority of the allottee to obligate funds appropriated by this act shall not
22	lapse.
