CONGRESSIONAL BILL No. 4-37, C.D.1, C.D.2,

AN ACT

To further amend Public Law No. 3-48, as amended by Public Law No. 3-69, by amending sections 1, 2, 4, 5 and 7, for the purpose of appropriating the sum of \$498,186 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, as supplemental funding for the Departments of External Affairs and Resources and Development, the Office of the Attorney General, the legislative branch, the Commission on Future Political Status and Transition, and Postal Services, to reapportion funds for the Public Auditor, to raise the employment ceiling of the legislative branch, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-48, as amended by Public
2 Law No. 3-69, is hereby further amended to read as follows:

3 "Section 1. Operating expenses of the executive branch. The
4 sum of \$728,329, or so much thereof as may be necessary,
5 is hereby appropriated from the General Fund of the Federated
6 States of Micronesia, and the sum of \$5,653,915, or so much
7 thereof as may be necessary, is hereby appropriated from the
8 United States Grant Special Fund for the fiscal year ending
9 September 30, 1985, for the operations of the executive branch
10 of the National Government of the Federated States of Micronesia
11 during fiscal year 1985. The sums appropriated by this section
12 shall be apportioned as follows:

17 fiscal year 1985. The sums appropriated by this section shall be
18 apportioned as follows:

13 agencies, commissions, authorities, boards, bureaus, and other
14 organizations of the National Government of the Federated States
15 of Micronesia during fiscal year 1985. The sums appropriated by

15 (2) The number of positions authorized applies individu-
16 ally to each of the departments and offices of the executive and
17 legislative branches, the National judiciary, the Public Auditor,
18 and to the agencies as provided in subsection (1) of this
19 section, except that the President may transfer up to 12
20 positions between the departments and offices of the executive
21 branch. This authorization of positions covers all permanent
22 employees, all contract personnel whose employment extends for 1
23 year or more, and all positions funded from United States federal
24 programs. No funds may be expended for unbudgeted positions."
