

APPROPRIATION ACT 1986

EXPLANATORY MEMORANDUM

1. This proposed Act seeks to charge upon the Consolidated Fund the sums required for the recurrent expenditure for the year ending 31st December, 1987.
2. The Schedule to the Act specifies the heads of expenditure for which the sum, in the aggregate, is appropriated, and in the case of each one of the heads of expenditure, the particular amount, out of the total, appropriated to it.
3. The heads of expenditure specified in the Schedule are those which are contained in the Estimates for the financial year ending on 31st December 1987.
4. This proposed Act is presented in accordance with the provisions of section 109(1) and (2) of the Constitution.
