Short title.

1. This Act may be cited as the Supplementary Appropriation  
(No. 2) Act, 1979.

Authorisation  
of issue of  
1,636,041  
from the  
Consolidated  
Fund.

2. The issue from the Consolidated Fund is hereby authorised  
of a sum of four million six hundred and thirty six thousand  
and forty one dollars to be applied for recurrent expenditure  
to the service of the year ending on December 31, 1979.

Appropriation.

3. The sum specified in Section 2 shall be appropriated  
for the supply of the Heads of Expenditure specified in  
Column 1 of the Schedule annexed to this Ordinance in the  
sums respectively set forth in relation thereto in Column 2  
of the Schedule.

SUPPLEMENTARY APPROPRIATION (NO. 2) ACT, 1979.

EXPLANATORY MEMORANDUM.

1. This Bill charges upon the Consolidated Fund a sum which is required for recurrent expenditure for the year ending on December 31, 1979, in addition to the amount appropriated for that year by the Appropriation Ordinance, 1978.
2. The sum required is to provide for monies expended in excess of sums already appropriated, and for monies expended for which no monies have yet been appropriated.
3. The Bill provides that the additional amounts charged shall be divided between and expended upon the services listed in the Schedule to the Bill.
4. The Bill is presented to the Maneaba in accordance with the requirements of Section 109(3) of the Constitution.
