Short title

1. This Act may be cited as the Supplementary Appropriation (No. 2) Act 1997.

Authorisation of issue of \$909,571 from the Consolidated Fund

2. The issue from the Consolidated Fund is hereby authorised of a sum of \$909,571 to be applied for recurrent expenditure to the service of the year ending 31 December 1997.





SUPPLEMENTARY APPROPRIATION (NO. 2) ACT 1997

EXPLANATORY MEMORANDUM

1. This Act charges upon the Consolidated Fund a sum, which is required for recurrent expenditure for the year ending 31 December 1997, in addition to the amount appropriated for that year by the Appropriation Act 1996, and the Supplementary Appropriation Act 1997.
2. The sums required are to provide for money expended in excess of sums already appropriated.
3. The Act provides that the additional amount charged shall be expended upon the service listed in the Schedule to the Bill.
4. The Act is presented to the Maneaba ni Maungatabu in accordance with the requirements of section 109(3) of the Constitution.
