

**AN ACT TO AUTHORISE SUPPLEMENTARY APPROPRIATION OF MONIES
OUT OF THE CONSOLIDATED FUND FOR RECURRENT EXPENDITURE FOR
THE SERVICE OF THE YEAR ENDING 31 DECEMBER 2021 (NUMBER 2)**

MADE by the Maneaba ni Maungatabu and assented to by the Beretitenti.

Short title:

1. This Act may be cited as the Supplementary Appropriation (No.2) Act 2021.

Authorisation of issue of \$23,468,619 from the Consolidated Fund

2. The issue from the Consolidated Fund is hereby authorized of a sum of \$23,468,619 to be applied for recurrent expenditure to the service of the year ending 31 December 2021.

Appropriation

3. The sum specified in section 2 shall be appropriated for the supply of the Heads of Expenditure specified in Column 1 of the Schedule annexed to this Act in the sums respectively specified in relation thereto in Column 2 of the Schedule.

- This Act charges upon the Consolidated Fund a sum which is required for recurrent expenditure for the year ending December 2021.
- The Act provides that this additional amount charged upon the Consolidated Fund shall be divided between and expended upon the services listed in the Schedule to the Act.
- The Act is presented to the Maneaba ni Maungatabu in accordance with the requirements of section 109(3) of the Constitution.
