**CONSTITUTIONAL CONVENTION (AMENDMENT) (1)
ACT 2017.**

AN ACT to amend the Constitutional Convention Act 2015, in order to include additional proposal for the amendment of the Constitution of the Republic of the Marshall Islands.

BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

§101. Short title.

This Act may be cited as the *Constitutional Convention (Amendment) (1) Act 2017*.

§102. Amendment.

(1) Schedule 1 of the *Constitutional Convention Act 2015* is hereby amended by inserting a new proposal in the schedule to read as follows:

Proposal No. 23 - Article VIII, Section 15(2) of the Constitution of the Republic of the Marshall Islands to provide for the Auditor-General the ability to determine all matters relating to the employment of staff to bring the OAG in line with international best practice and United Nations Resolutions. To enable the Auditor General to responsible for employment and termination of staff, Article VIII, Section 15(2) of the Constitutions of the Public Service is amended to read as follows:

“The Auditor-General may exercise his responsibilities under paragraph (1) of this Section either in person or through officers who are subordinate to him, acting in accordance with his general or special instructions.”

§103. Effective Date


This Act shall take effect on the date of certification in accordance with Article IV, Section 21 of the Constitution.
