



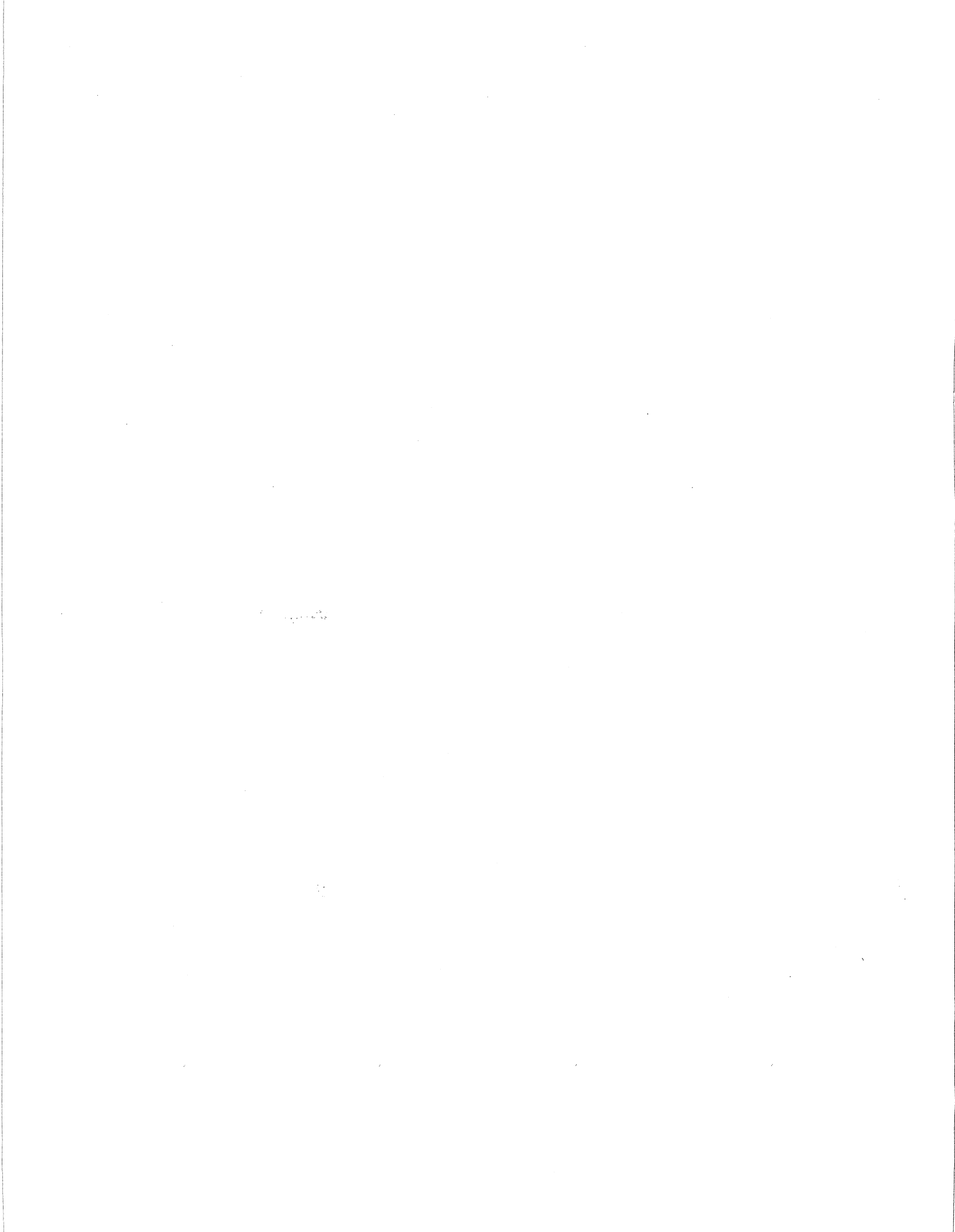

AN ACT to amend the Constitutional Convention Act in order to (i) increase the number of sitting days for the Convention to 60 days, and (ii) increase sitting allowance to \$100

BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

§101. Short title.

This Act may be cited as the *Constitutional Convention (Amendment)(9) Act 2016*.

§102. Amendment.

(1) Section 410) of the *Constitutional Convention Act* is amended as follows:

§410. Session of the Convention.

The Convention shall convene in Majuro within one month of the date of ~~the election of~~ the members and shall remain in session for a period of not more than sixty (60) sitting days. The term "sitting days" as used herein shall have the same meaning as defined under the Rules of the Procedures of the Nitijela.

(2) Section 410) of the *Constitutional Convention Act* is amended as follows:

§418. Compensation.

- (2) All members of the Convention shall be entitled to a sitting allowance at the Rates of one hundred dollars (\$100.00) per sitting day.

§103. Effective date.
