DISASTER ASSISTANCE (AMENDMENT) ACT, 2018

AN ACT to increase the total appropriated amount provided under the Disaster Assistance Act of 1987 from \$200,000 to an additional increase of \$100,000 totalled to \$500,000 to reflect the appropriated amount of \$500,000 provided under the Appropriation (Financial Year 2019) Act, 2018.

BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

§101. Short title.

This Act may be cited as the *Disaster Assistance (Amendment) Act, 2018*.

§102. Amendment.

Section 1010 (2) shall be amended to which it should read as follows:

§1010. Finance.

- (1) The Disaster Assistance Account is hereby established as a special revenue account within the National Treasury and under the control and supervision of the Ministry of Finance, which shall provide for its administration in accordance with the Financial Management Act of 1990, as amended, 11 MIRC 1.
- (2) In the event that at all or any part of the Account is utilized for any of the purposes under this Chapter during any financial year, the amount so utilized shall be appropriated in the Annual Appropriation Act for the next financial year in order to maintain a continuous balance of \$500,000 in the Account at the commencement of each fiscal year.

§103. Effective date.

This Act shall take effect on the date of certification in accordance with the Constitution and the Rules of Procedures for the Nitijela.


