6	Section 1. Short Title.
7	This Act may be cited as the Judicial Compensation (Amendment) Act of 2001.
8	Section 2. Amendments.
10	The Judicial Compensation Act 1983, as amended, 27 MIRC, Chapter 4 ("the
11	principal Act"), is amended as follows:
12 13	(A) Subsection (1) of Section 402 of the principal Act is amended to read as follows:

16	Chief Justice of the Supreme Court \$30,000
17	Associate Judge of the Supreme Court \$25,000
18	Chief Justice of the High Court \$55,000-\$60,000
19	Associate Justice of the High Court \$50,000-\$55,000
20	Presiding Judge of the District Court \$28,000-\$30,000
21	Associate Judge of the District Court \$25,000- \$27,000

(B) Section 403 of the principal Act is amended to read as follows:
"Section 403. Compensation of Judges of the Community Courts.
The annual salary of a judge of a Community Court is
\$2,400."

effective date of Section 403 of the principal Act, as amended by Section 2 of this Act, shall take
effect on such date as the Cabinet, acting on the recommendation of the Judicial Service
Commission, shall determine.
Section 4. Effective Date.

Section 21 of the Constitution.
