**LOCAL GOVERNMENT (AMENDMENT) ACT 2020.**

5 **A BILL FOR AN ACT** to amend 4 MIRC Ch. 1 to provide for direct election of the  
6 Mayor at each General Election and provide for the replacement of any local  
7 government council members at each General Election.

8 **BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

9 **§101. Short title.**

10 This Act may be cited as the Local Government (Amendment) Act 2020.

11 **§102. Amendment.**

12 (1) Section 10 of the Local Government Act is hereby amended as follows:

14 §10. Casual Vacancies

15  
16 (2) Section 10 of the Local Government Act is hereby amended as follows:

17 §127. Announcement of election.

18 (1) When an election is to be held, a certifying officer shall, in  
19 whatever manner is customary in the area concerned for  
20 the announcement of important news, announce two  
21 election meetings, on dates approximately one week apart.

22  
23 a. If there is an announcement that a council member  
24 dies, resigns or otherwise vacates his/her seat, the

1 seat shall be filled by the candidate receiving the  
2 next highest number of votes at the most recent  
3 general election. If there was no other candidate at  
4 the most recent general election the seat shall remain  
5 vacant for the remainder of the term.  
6

7 (2) Mayors shall be elected by eligible voters in the general  
8 election on the basis of a direct and secret ballot .

- 9 a. Special elections may be held for the replacement of Mayor  
10 at anytime.
- 11 b. The certifying officer shall announce a special  
12 election approximately thirty (30) days prior to its  
13 occurrence.  
14

15 (3) If a council member dies, resigns or otherwise vacates his/her seat, the  
16 seat shall be filled by the candidate receiving the next highest number  
17 of votes at the most recent general election. If there was no other  
18 candidate at the most recent general election the seat shall remain  
19 vacant for the remainder of the term.  
20

21 **§103. Effective Date.**

22 This Act shall take effect on the date certification in accordance with the  
23 Constitution and the Rules of Procedures of the Nitijela.


