This Act may be cited as the Parole of Prisoners Act of 2001. 13 14 Section 2. Purpose of the Act. 15 The purpose of this Act is to establish the Parole of Prisoners Board. Section 3. Definitions. 16 In this Act, unless the context otherwise requires: 17 (1) "Minister" means the Minister to whom the responsibility of the Ministry of 18 19 Justice has been assigned by the President; 20 (2) "Parole" means the conditional and revocable release of a prisoner serving an unexpired sentence in prison or any correctional institution; 21 (3) "Parole Board" means the Parole of Prisoners Board established under Section 22 4 of this Act. 23 Section 4. Parole Board. 24 (1) There is hereby established a Parole of Prisoners Board which shall consist 25 26 of:

4	make recommendations to the Attorney-General for the revocation or suspension of such parole,	
5	and upon court order, provide the facilities for the return to the correctional institution of the	
6	paroled person;	
7	(g) discharge a person from parole when supervision is no longer needed;

9	(h) send on a bi-annual basis, a detailed report of its operations to the	
10	Minister, who shall transmit such report to Cabinet.	
11	(2) Any Regulations for the time being in force, regulating the granting of pardon	
12	and parole, shall to the extent that they are not inconsistent with this Act or any other law, remain	
13	applicable and have the force and effect of law.	
14	Section 7. Effective Date.	
15	This Act shall take effect on the date of certification in accordance with Article	
16	IV, Section 21 of the Constitution.
