recommend the conditional release of prisoners, who in the opinion of the Probation Officer, as	
suitable for such release.	
(2) The report of the Probation Officer recommen	ding such release shall state
reasons for such release and he submitted to the Superintendent	of Dricone who along with his

The Parole Board may, subject to such terms and conditions as may be prescribed
in any other law or applicable regulations for granting of parole, and acting on the report and
recommendations referred to in Section 531 of this Chapter, either release the prisoner on parole
as recommended or release the prisoner subject to such terms and conditions as it may deem fit,
or decline to grant parole to the prisoner."
Section 3. Effective Date.
This Act shall take effect on the date of certification in accordance with Article
IV, Section 21 of the Constitution.
