13		"(c) "National Statistician" means the Director of the Economic Policy,

15	(2)	Section 1003 (1) and (2) are hereby amended to read in the following manner;
16		"(1) The Director of the Economic Policy, Planning and Statistics Office
17		shall serve ex-officio as National Statistician who shall have and may exercise
18		powers and functions as are conferred by this Chapter.
19		"(2) Subject to the approval of the Public Service Commission, the

2	National Statistician may, for the purpose of the performance of any of his duties	
3	under this Chapter, employ such persons in addition to the staff of the Economic
