**STATE-OWNED ENTERPRISES (AMENDMENT) ACT, 2022**

A BILL FOR AN ACT to delist the Marshall Islands National Telecommunication Authority (MINTA) and the Marshall Islands Ports Authority (RMIPA) from the list of State-Owned Enterprises (SOEs), and enlist the Office of Commerce, Investment, and Tourism (OCIT), as stipulated under the SOE Act, 2015.

**BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS**

**§101. Short title.**

This Act may be cited as State-Owned Enterprises (Amendment) Act, 2022.

**§102. Amendments**


