

YOUTH SERVICE CORPS (AMENDMENT) ACT, 2018

AN ACT to amend the Youth Service Corps At, 2016 to have it managed by the College of the Marshall Islands.

BE IT ENACTED BY THE NITIJELA OF THE REPUBLIC OF THE MARSHALL ISLANDS

§101. Short title.

This Act may be cited as the Youth Service Corps (Amendment) Act, 2018.

§102. Amendments.

Section 402 is amended to which it reads as follows:

§402. Interpretation.

In this Chapter, unless the context requires;

"Act" shall mean this Youth Service Corps Acct, 2016;

"College of the Marshall Islands" shall mean the College established under Section 204 of the College of the Marshall Islands Act of 10992";

"Corps" shall mean the Youth Service Corps established under this Act;

§407. Management of the Corps.

(1) Subject to this Act and the Regulations made under Section 26, the Corps shall be controlled and managed by the College of the Marshall Islands.

- (2) The College of the Marshall Islands Board has and may exercise and perform all the powers and functions of the Corps made under this Chapter.
- (3) Section 408, 409, 410, 411 and 413 are hereby repealed in their entirety.
- (4) Any reference to the "Board" is to be revised to the "College of the Marshall Islands".

§103. Effective Date.

This Act shall take effect in accordance with the Constitution and the Rules of Procedures of the Nitijela, provided that nothing herein shall take effective until three (3) months following the date of enactment of this Act.
