ORDER

WHEREAS

On the 23 June 1998, the Supreme Court made an order in the 'MINUTE OF DILLON J.' that:-

(a) The Nauru Lands Committee is to convene a meeting of all interested parties to review the decision made in 1994 and why it was at variance with it's previous decision in 1990, and if appropriate, issue a new amended gazette notice;

(b) Pending the Nauru Lands Committee making a final decision as aforesaid, all phosphate royalties derived from these lands are to be paid into this court to be held in an interest bearing account with the Bank of Nauru.

AND WHEREAS

The Supreme Court is now satisfied that paragraph (a) of the said order as aforesaid having been duly completed by way of a determination having been published in gazette notice 285/1998 in gazette number 70 dated 18th November 1998,

AND WHEREAS

BY CONSENT, the shareholdings are now amended as per the schedule attached to this order, to reflect the true and accurate share fractionals, without any change to the beneficiaries,

NOW THEREFORE BE IT ORDERED AS FOLLOWS:-

All moneys held in trust by the Supreme Court or otherwise; they being moneys due and payable as a consequence of the said determination made by the Nauru Lands Committee as published in the aforementioned gazette notice and as copied to the Supreme Court in the Nauru Lands Committee letter dated 12th November 1998, they being moneys for portions 376 p.l. and 377 p.l. Mereberen, Anibare, shall be paid out forthwith to the said landowners inclusive of interest accumulated since the time of the said deposits, as follows:-
