

By consent:

1. the decisions of the Nauru Lands Committee as regards the distribution of the estate of Alfred Abatsir Ika, evidenced by Gazette Notice Numbers 30/1985 (23 January 1985), 31/1990 (31 January 1990), 246/2001 (10 October 2001) and 251/2002 (18 December 2002) are set aside, and the manner of the distribution of the estate of Alfred Abatsir Ika is returned to the Nauru Lands Committee to be determined afresh;
2. insofar as the fresh determination of the distribution of the estate of Alfred Abatsir Ika will affect the distribution of the estates of Ika Ditto (Gazette Notice Number 303/1986, 2 July 1986) and Adioran Ika (Gazette Notice Number 169/1999, 4 August 1999), the Nauru Lands Committee is directed to adjust the shares of the beneficiaries of those estates to ensure that the beneficiaries of the estate of Alfred Abatsir Ika (as determined afresh) receive the shares due to that estate;
3. payments made from the interest of the Nauruan Land Owners Royalty Trust Fund (Ronwan) by the Nauru Phosphate Royalties Trust to persons in respect of the estate of Alfred Abatsir Ika (through the Curator of Intestate Estates) prior to 8 July 2010 are to stand, and will not be further challenged;
4. no further payments are to be made by the Curator of Intestate Estates in respect of the estate of Alfred Abatsir Ika until the fresh determination of the distribution of that estate is completed by the Nauru Lands Committee;
5. Civil Cases 8/2010, 17/2011 and 37/2011 are withdrawn and dismissed; and
6. parties are to have liberty to apply in the event that further directions are required.






