DETERMINATION OF THE PUBLIC SERVICE COMMISSIONER WITH RESPECT
TO OFFICERS AND EMPLOYEES OF THE RADIO
STATION NAURU

In accordance with the powers conferred upon me by virtue of Section 39 Sub-section (4) of the Public Service Act 1961-1971, I determine:-

- (i) that the hours of duty for officers and employees of the Radio Station, Nauru, shall be worked between the hours of 7.00 a.m. and 10.00 p.m. on each day of the week, Monday to Sunday inclusive,
