COPORATION ACT 1972

CORPORATION (PRESCRIBED FEES) (AMENDMENT) REGULATIONS 1979

IN EXERCISE of the powers conferred on it be section 243 of the Corporation Act 1972, the Cabinet has made the following Regulations-

TITLE AND COMMENCEMENT

1. These Regulations may be cited as the Corporation (Prescribed Fees) (Amendment) Regulations 1979 and shall come into force on the twenty-eighth day following the day on which they are made.

INTERPRETATION

2. In these Regulations "the principal Regulations" means the Corporation (Prescribed Fees) Regulations 1972.

AMENDMENT OF PRINCIPAL REGULATIONS

- 3. (1) The principal Regulations shall be amended by the deletion of the Schedule thereto and the substitution for such Schedule of the Schedule to these Regulations.
- (2) Regulations 2 of the principal Regulations shall, in respect of any matter thing or event arising on or after the day on which these Regulations come into force, be construed and applied by reference to the Schedule to these Regulations, but in respect of any matter thing or event arising before such day shall continue to be construed and
