ARTICLE 68(3)

APPOINTMENT OF SECRETARY FOR ISLAND DEVELOPMENT & INDUSTRY

IN PURSUANCE of Article 68 of the Constitution, and with the consent of Cabinet under Article 68(3) KINZA GODFREY CLODUMAR has been appointed to be Secretary for Island Development and Industry with effect from 16th May, 1979.

Mr. Clodumar has therefore, with effect from the same date, been promoted from the post of Director of Civil Aviation to that of Secretary for Island Development and Industry.
