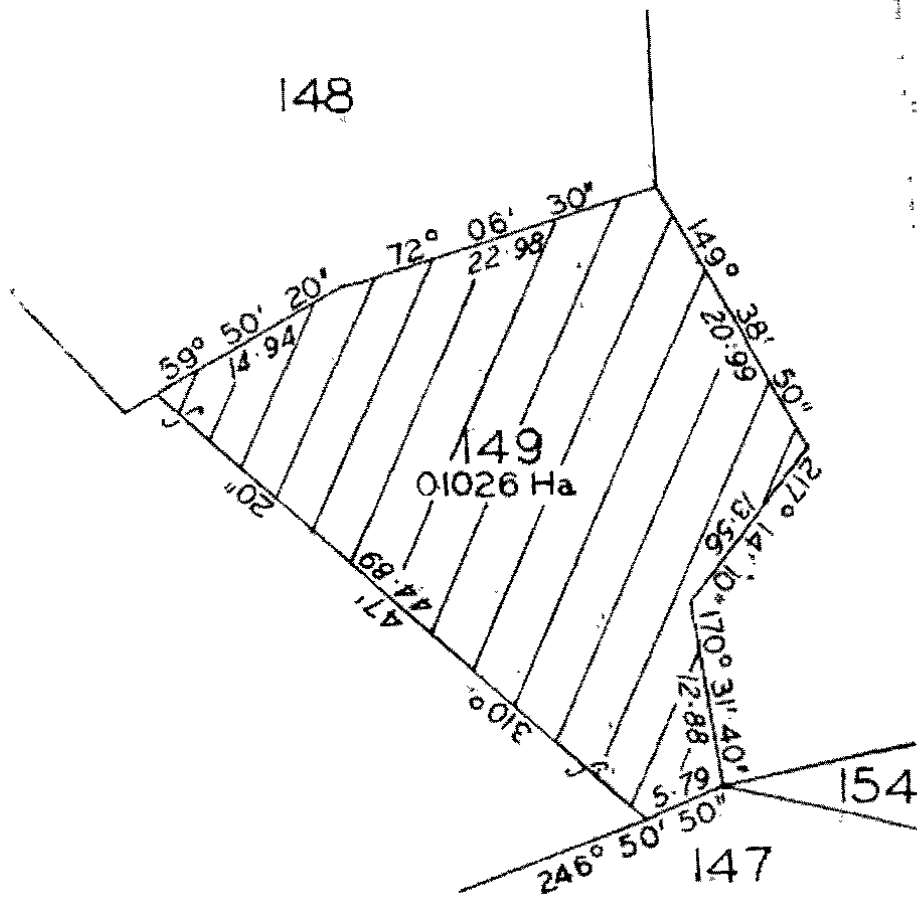

SCALE : 1:500.



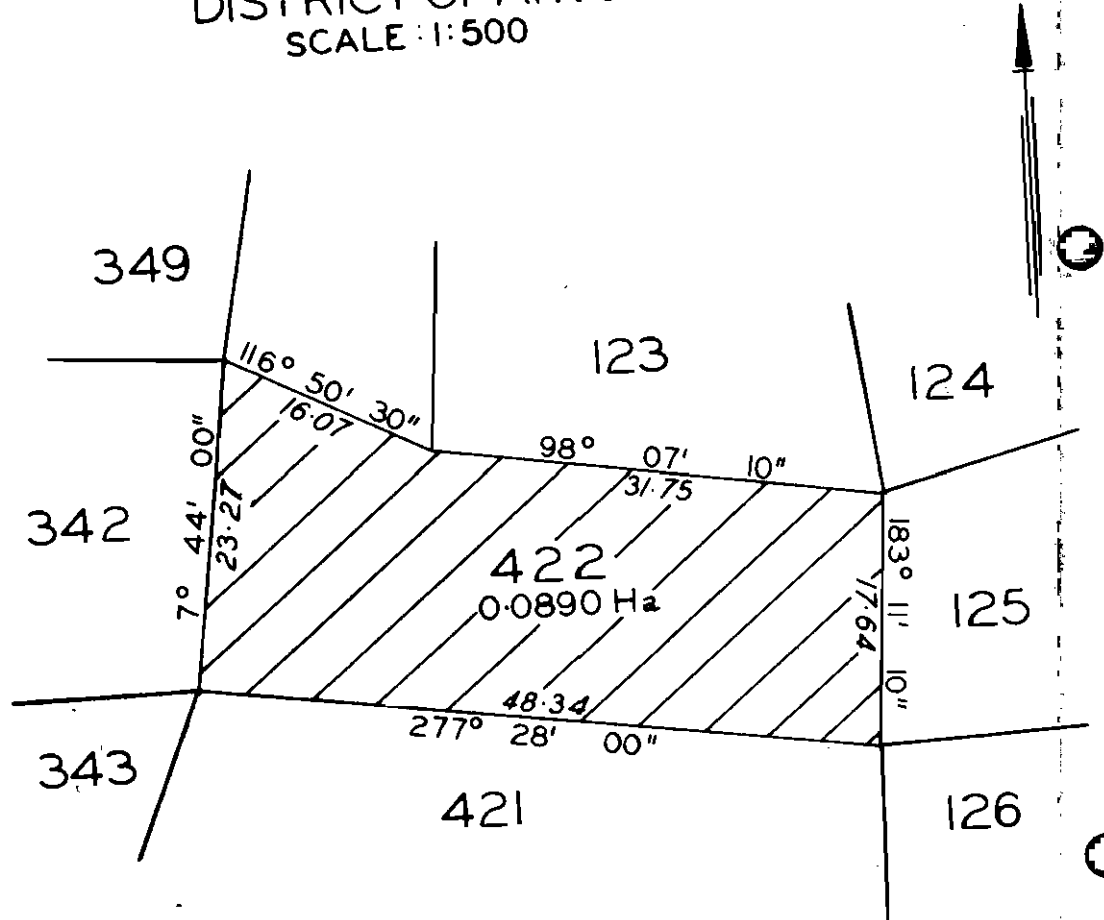

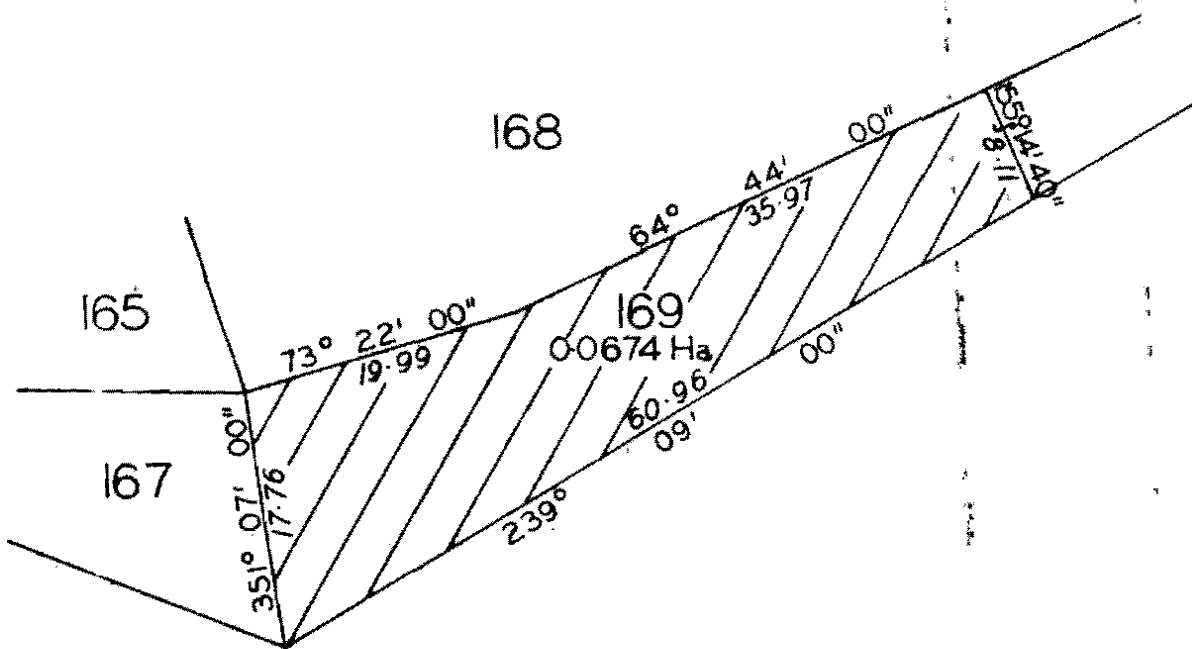
