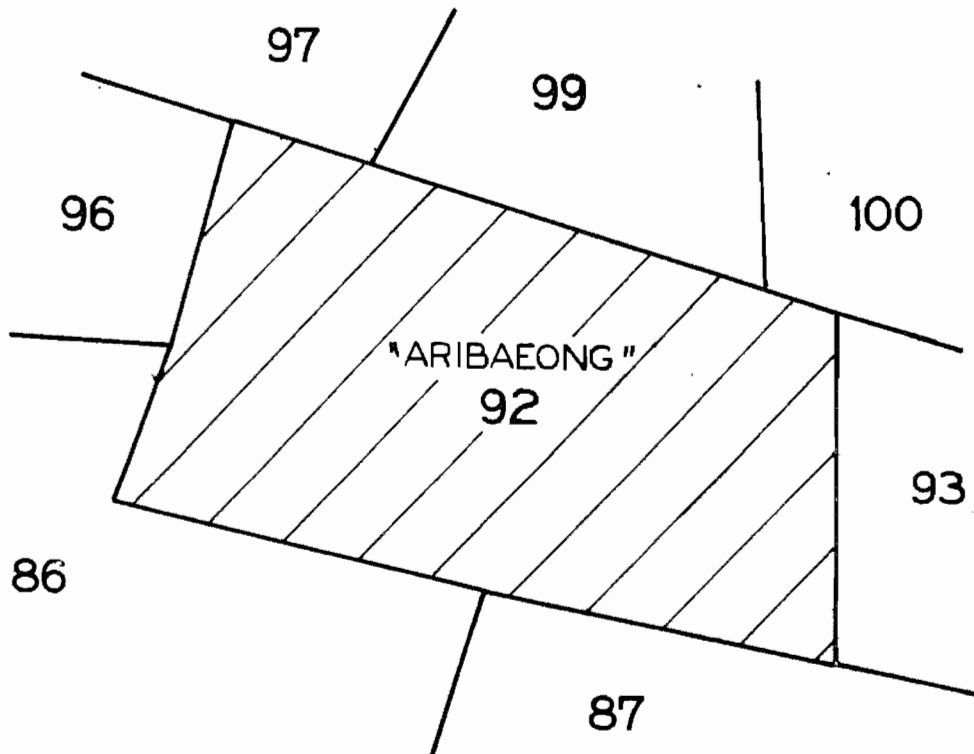
# DISTRICT OF ANIBARE

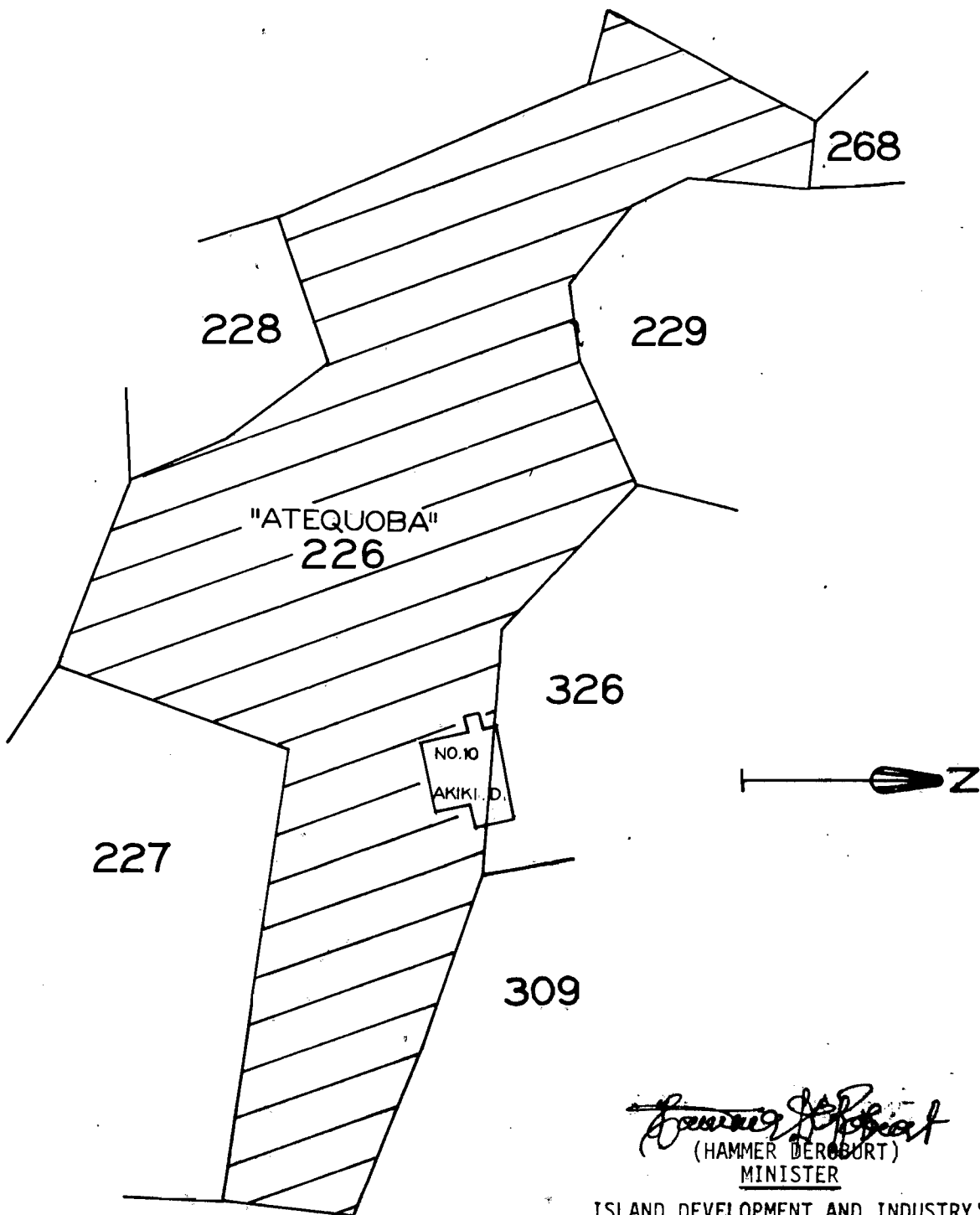


# DISTRICT OF BUADA
