CONSTITUTION OF NAURU
ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS

IN EXERCISE of the Powers in that behalf vested in His Excellency The President, under article 23 of the Constitution of Nauru, I, HAMMMER DEROBURT, President of The Republic of Nauru, hereby assign to The Ministers of The Cabinet of Nauru, set out below, The responsibilities of the Business of the Government of Nauru as set out opposite their names:

MINISTER FOR WORKS AND
COMMUNITY SERVICES

The Portfolio of The President, External and Internal Affairs and The Public Service in relation to the Business of Government to be undertaken in Nauru by the said Minister.

MINISTER FOR FINANCE

The Portfolio of the Minister for Island Development and Industry in relation to the Business of Government to be undertaken in Nauru by the said Minister.

The assignment of Business of Government of Nauru as set out above is in addition to and not in substitution for the Business of Government of Nauru already assigned to the said Ministers. The above assignments of responsibility for the Business of Government shall be effective during the absence from The Republic of His Excellency President HAMMER DEROBURT, G.C.M.G., O.B.E., M.P.

MINISTER FOR JUSTICE

The Portfolio of The Minister for Island Development and Industry in relation to the Business of Government to be undertaken in Nauru by the said Minister.

The assignment of the Business of the Government of Nauru as set out above is in addition to and not in substitution of the Business of The Government of Nauru already assigned to the said Ministers. The above assignments of responsibility for the Business of Government shall be effective during the absence from The Republic of His Excellency President HAMMER DEROBURT, G.C M.G., O.B.E., M.P. and The Honourable KENAS AROI, M.P., Minister for Finance.
