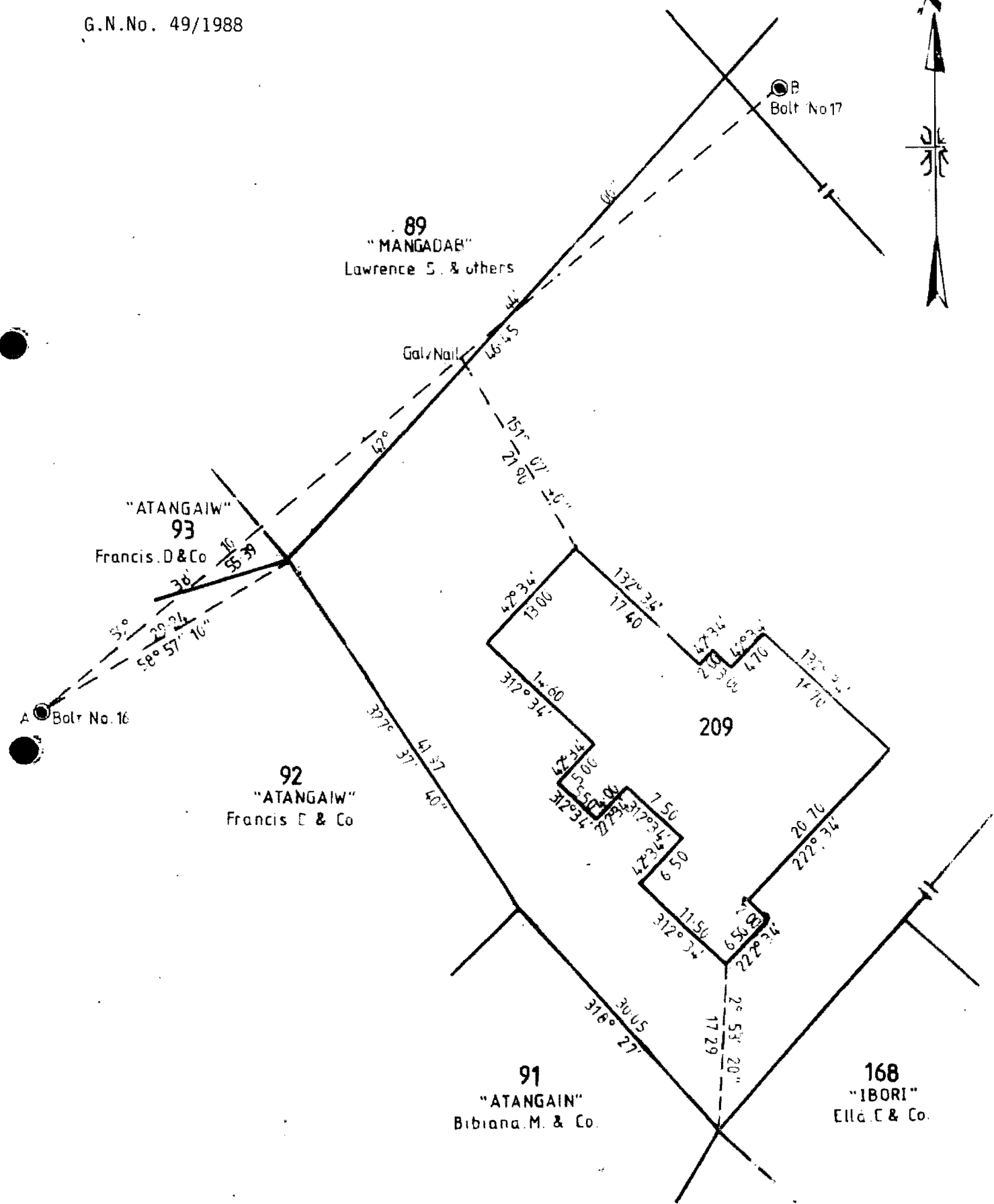

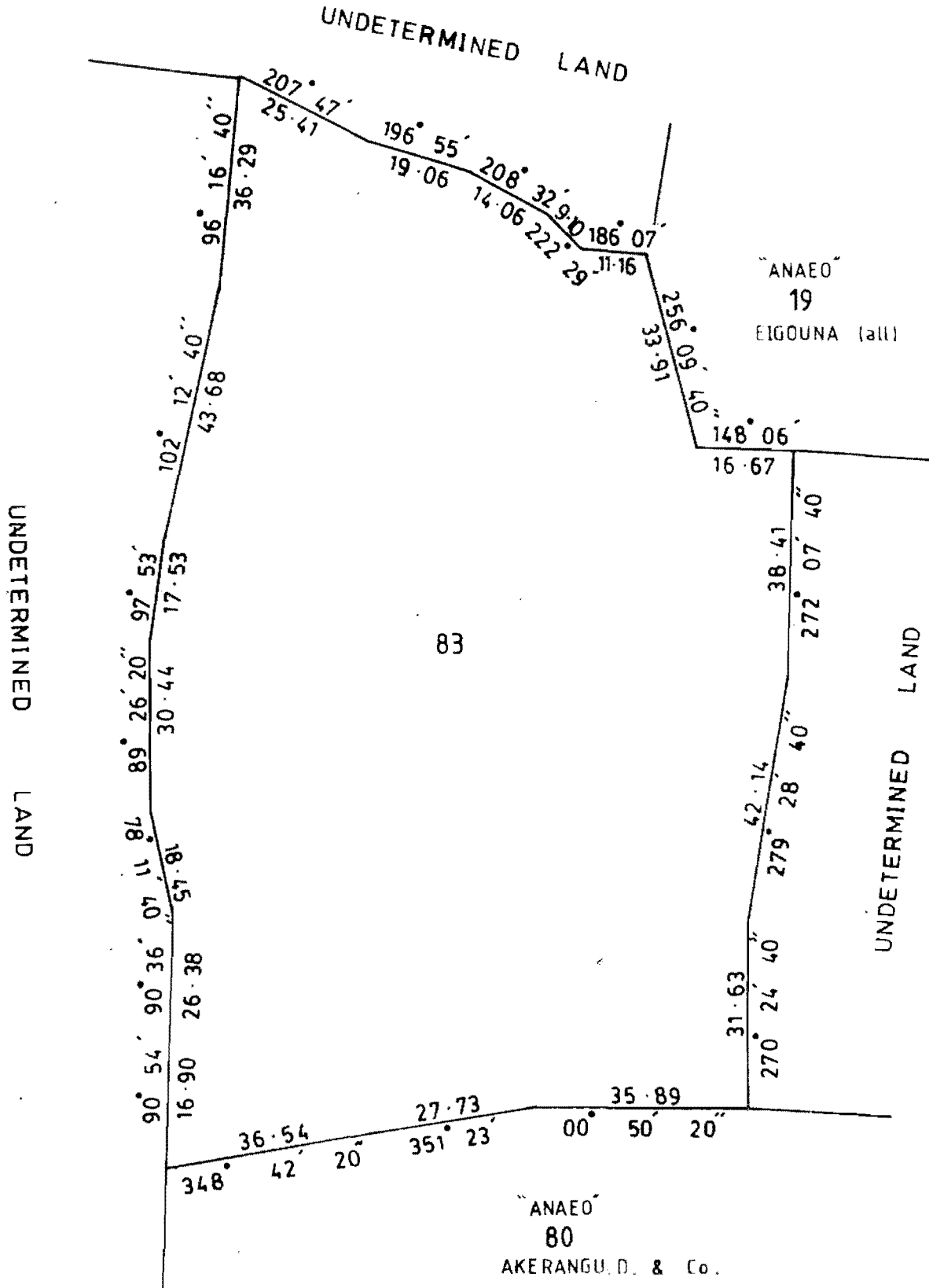


DISTRICT OF IUW

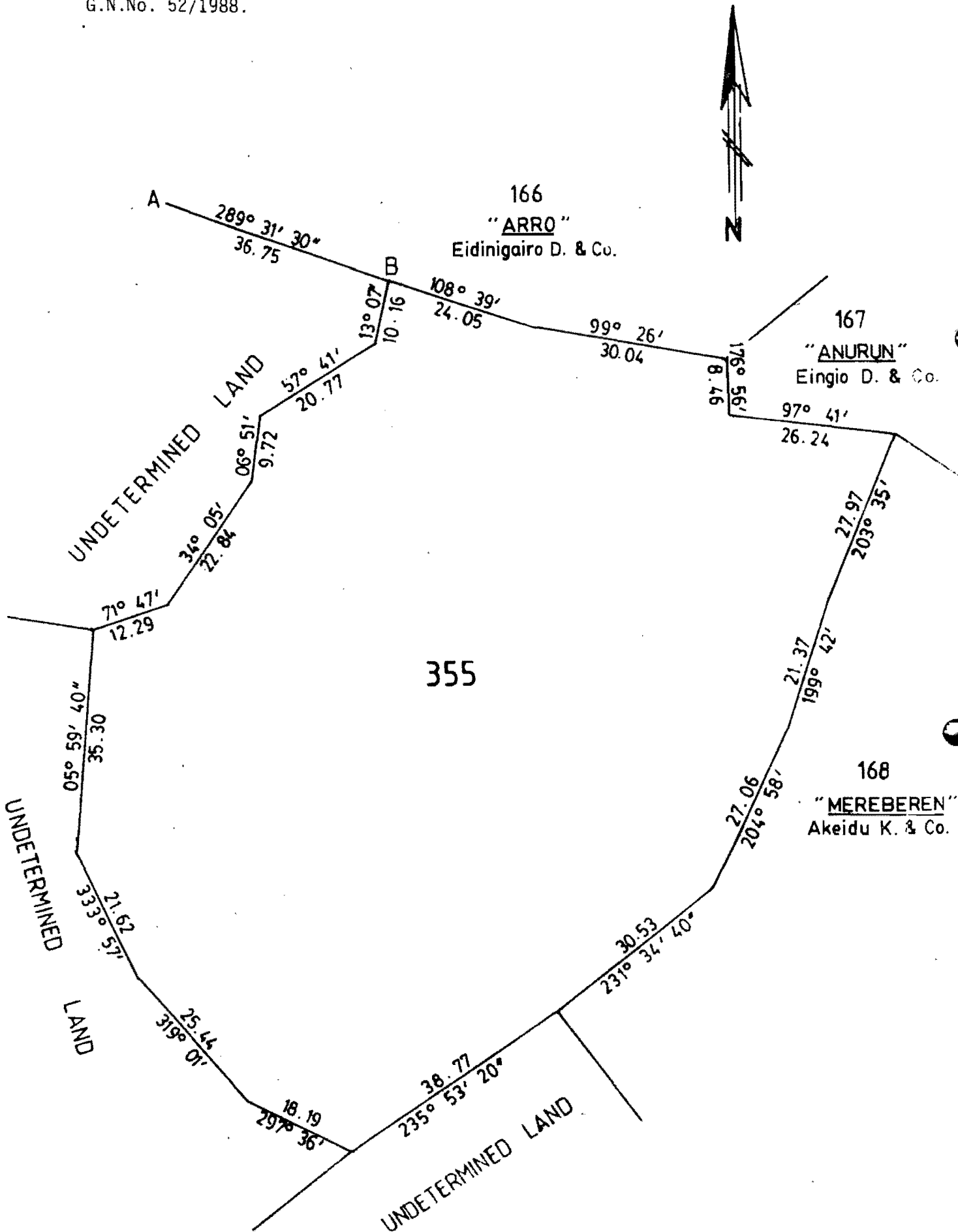

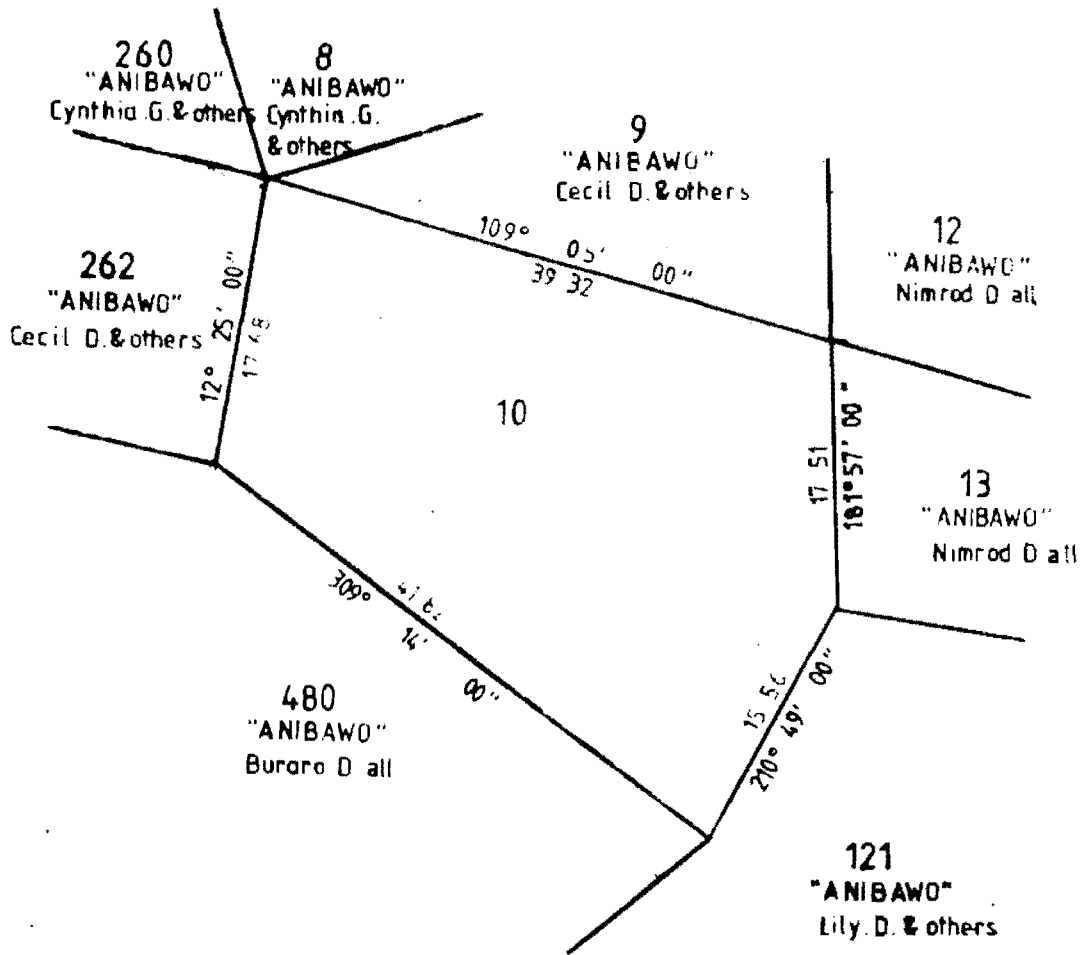
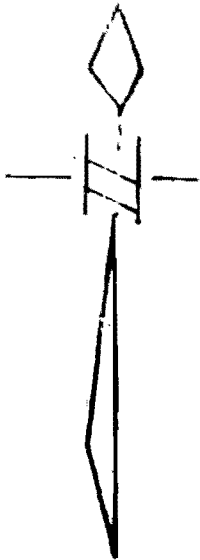
