CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS
OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, HAMMER DEROBURT, PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTERS OF THE CABINET OF NAURU, SET OUT BELOW, THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE THEIR NAMES:-

MINISTERS OF CABINET

MINISTER FOR JUSTICE

MINISTER FOR HEALTH
AND EDUCATION

MINISTER FOR FINANCE

BUSINESS OF GOVERNMENT

THE PORTFOLIOS OF THE PRESIDENT, EXTERNAL AFFAIRS, INTERNAL AFFAIRS AND THE PUBLIC SERVICE IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENT OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION OF THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTERS. THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENTS SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF HIS EXCELLENCY THE PRESIDENT HAMMER DEROBURT, G.C.M.G., O.B.E., M.P., AND THE HONOURABLE BURARO DETUDAMO, M.P., MINISTER FOR WORKS AND COMMUNITY SERVICES.

CONSTITUTION OF NAURU

APPOINTMENT OF CABINET UNDER ARTICLE 21

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT,
UNDER ARTILE 21 OF THE CONSTITUTION OF NAURU, CABINET
HEEREBY APPOINTS THE HONOURABLE BERNARD DOWIYOGO, BEING
MINISTER FOR JUSTICE AND A MEMBER OF THE CABINET OF NAURU,
TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE
PRESIDENT IN NAURU DURING THE PERIOD OF ABSENCE FROM THE
REPUBLIC OF HIS EXCELLENCY PRESIDENT HAMMER DEROBURT,
G.C.M.G., O.B.E., M.P.
