- 1) Pursuant to Section 7, subsection (1) of the Nauru Phosphate Royalties Trust Ordinance 1968, terminated the appointment of Mr. David Allan Morgan (appointed by Cabinet under Section 5 subsection (1) Clause (b) of the Trust Ordinance) with effect from 22nd December, 1989;
- 2) Pursuant to Section 5, subsection (1) Clause (b) of the Trust Ordinance, appointed Mr. Theodore Conrad Moses, the Republic's Consul-General in Melbourne, to be a member of the Trust with effect from 22nd December, 1989;
- 3) Pursuant to Section 12, subsection (1) of the Trust Ordinance, simultaneously appointed Mr. Theodore Conrad Moses to be the Chairman of the Trust with effect from 22nd December, 1989; and
- 4) Recognised the appointment by the Nauru Local Government Council of Mr. David Allan Morgan to be a member of the Trust, pursuant to Section 5, subsection (1) Clause (c) of the Ordinance, with effect from 22nd December, 1989.

CONDITION FOR THE AWARD OF SCHOLARSHIPS

IT IS NOTIFIED for general information that the Cabinet has, at its meeting held on 2nd April, 1990, approved the following:-

CONDITIONS OF AWARD OF SCHOLARSHIPS

- 1) A candidate who is a Nauruan citizen and who is within the age limit determined in paragraph 7 below, is eligible to sit the examination and be awarded a scholarship;
- 2) A maximum of 10 scholarships may be awarded at each level;

- 3) A scaled score of more than one standard deviation above the Mean in the scholarship examination (which is approximately equal to 65% pass) constitutes the cut-off point for the purpose of the scholarship awards. Any candidate who attains a scaled score to or greater than the cut-off point is eligible for award of scholarship. The awards will be given in descending order of marks up to ten awards at each level. The Cabinet, upon recommendation of the Minister, may award a higher number of scholarships if the circumstances warrant;
- 4) If the number of candidates who attain a score equal to or higher than the cut-off point is less than the number of awards available, the Cabinet, on the recommendation of the Minister, may award scholarships to candidates who score marks below the cut-off point if the candidates meet the following criteria -
 - (a) if a candidate's total scale score is above the Mean; and
 - (b) that the total educational record indicates that the candidate has maintained good record of attendance, social behaviour, and high academic achievements at class examinations;
- 5) Publication of the results of the scholarship examinations will be made through Government media for candidates who achieve a scaled score equal to or greater than the Mean;
- 6) The Cabinet, on the recommendation of the Minister, may withdraw scholarship from an awardee if the behaviour and performance of the awardee warrant such action;
- 7) A student may sit the scholarship examination once only at each level. A Grade six candidate who is over the age of 12 years and 6 months, or a Form four candidate who is over the age of 16 years and 6 months, on or before the 31st December in the year in which scholarship examinations are held, is not eligible to sit the examination except with the approval of the Minister.
