- POSITION:** Principal, Nauru Secondary School
- SALARY:** A\$14,298 - 14,946 (AP 6) per annum
- DUTIES:**
- (a) Ensuring that all teaching is with the curricula and syllabus material stipulated by the Director.
 - (b) Planning of the time-table and school supplies and supervision of the teaching and discipline within the school at his/her direction, some teaching of senior classes per week and ensuring that staff strength is utilised for maximum benefit of the pupils.
 - (c) The efficient ordering, distribution and control of supplies and equipment, and assistance with budgeting, and providing in service guidance to teachers and student-teachers on the staff
 - (d) Maintenance of staff and pupil morale and discipline, efficient management of all records and registers in the school.
 - (e) Liaison with parents through Parents and Citizens Association and School's Liaison Officer and liaising with other school's in Nauru.
 - (f) Such other duties compatible with the position as determined by the Director of Education.
- QUALIFICATION:**
- (a) Applicant should be graduates and should have sufficient teaching and administrative experience. A teacher Diploma/Degree is essential. Post graduate qualification is desirable though not essential.
 - (b) As English is the second language for Nauruans, teaching experience in English is essential. Equally important is clarity in spoken English.

(c) As teachers in the school are nationals from Nauru, Australia, Fiji, India, New Zealand and other countries, candidates should have understanding and tact in working in a multinational environment and ability to be firm in running school smoothly and efficiently and capacity to get along.
