THE DISTRICT COURT OF NAURU

IN THE MATTER of certain
Complaints herein scheduled

DECISION OF THE COURT

The cases listed below are cases in which the Court has declined jurisdiction.

The Criminal Code and the Criminal Procedure Act 1972 provide for time limits for the laying of complaints in respect of summary offences - see S.55L of the Code (1 year) S.159 of the Criminal Procedure Act (6 months).

Before a Court can deal with any offence, it must have jurisdiction to do so. That jurisdiction is given to it by the Complaint or Charge presented to it. The Complaint must:

- (a) Specify the defendant.
- (b) State the offence with which he is charged - that must be an offence prescribed by law.
- (c) Be sworn or taken before the Magistrate, that requires the Complaint to be signed by both the Complainant and the Magistrate taking it.
- (d) The date when it is taken must be recorded on the Complaint. This is very important since the time limit which determines whether the charge can lawfully be prosecuted is settled by this date.

The Court's jurisdiction depends upon such date which to jurisdiction, must be within the time limited for the prosecution of the offences charged. The Complaint must be signed by the Complainant and the Magistrate taking. It is important to understand it is not the time when the Complaint is filed in the Court Registry that is the relevant time. The time when the Magistrate takes the Complaint is that which decides whether the prosecution has been begun in time.

While it is possible to amend a Complaint after the commencement of the trials, before a trial can be commenced it must be shown, on the face of the Complaint presented to the Court, that the prosecution proposed is commenced within the time limit fixed by law. There is no jurisdiction to amend a Complaint before a trial commences. All the cases in question are founded on Complaints which do not show on their face that they are within time. Some are signed but not dated; some are not signed by a Magistrate as having been taken or sworn. Most concern summary offences which occurred over two years ago. Fortunately, most offences are relatively minor ones. There is no lawful way in which these Complaints can now confer jurisdiction on the Court. For that reason jurisdiction is declined. The Court considered each case and its prosecution to date. In all cases the proceedings were commenced with offences more than two years old. There has been in most of the cases no action taken at all to prosecute them. In some an initial mention in Court has been followed by complete inactivity by the prosecution and Court alike. In a few, the defendants have left Nauru, never to return.

Most of the cases are minor traffic offences. Delay of over 2 years in bringing cases of the nature of those considered here is inexcusable. To keep the defendants waiting to obtain justice as has been the case here will not be condoned.

As above stated they are "Dismissed for want of prosecution".
