SECTION 16

NOMINATIONS FOR BY-ELECTION

(BOE DISTRICT)

Intending candidates for by-election in the Constituency of Boe, are advised that:-

- a) Nominations can validly be made only after the Rolls have been closed (i.e., after Saturday, 1st August, 1992) and on or before nomination day (i.e., on or before Saturday, 8th August, 1992).
- b) Nominations papers may be handed to the Returning Officer at Chief Secretary's Office during Public Service hours from Monday, 3rd August, 1992 to Friday, 7th August, 1992 and between 8.00 am and 12:00 noon on Saturday, 8th August, 1992. To assist intending candidates, the Returning Officer will also be available in the Chief Secretary's Office on those days. Nomination will close at 12:00 noon on 8th August, 1992.
- c) Nominations must be made in Form 6 of the Schedule to the Electoral Act 1965-1973 and signed by at least two Electors who are on the Roll for the Electoral District of Boe and by the candidate. The intending candidate must also be an Elector whose name is on the Roll for the Electoral District of Boe. No nominations shall be valid unless they comply with the requirements of law.
- d) Nomination Forms are available from the Chief Secretary's Office.
- e) Candidates who have been duly nominated, and wish to withdraw their candidature may do so by notice in writing signed by them to the Returning Officer not later than 12:00 noon on Saturday, 15th August, 1992.
