- POSITION : ASSISTANT CHIEF ENGINEER
- SALARY : A\$25,561-26,104 p.a. (Nauruan)
- DUTIES : Assistant Chief Engineer's duties and responsibilities are required to be:
- a) Compliance with provisions of Republic of Nauru air navigation orders, regulations and Air Nauru maintenance system manual;
 - b) Compliance with the provisions of Australian Airlines limited-Air Nauru maintenance and engineering procedures manual;

- c) The performance of the maintenance, modifications of aircraft, including the support services contracted to Qantas airways and specified companies;
- d) Liaison with appropriate airworthiness authorities;
- e) Supervision of Nauru engineering staff including ground support maintenance staff;
- f) Shall be responsible to maintain storage standards of aircraft parts and materials at Nauru base in conformity with appropriate procedures;
- g) Maintenance of Kardex for complete inventory of aircraft parts and equipments owned by Air Nauru;
- h) In regard to stores procedure, Deputy Chief Engineer will be assisted by technical storekeeper;
- i) Whenever necessary Deputy Chief Engineer shall carry out aircraft maintenance to the extent of pre-flight checks ancillary checks including replacement of components;
- j) Upkeep and maintenance of technical library attached to engineering division. It involves manual revisions of airframe and engines;
- k) Ensure communications equipments including fax machine, micro-film reader printer, micro-fiche reader and sita telex terminals are always available in serviceable condition;
- l) Any other duties required during absence of Chief Engineer from the island.
