**CABINET ORDER NO.1
NAURU LOCAL GOVERNMENT COUNCIL
DISSOLUTION ORDER 1996**

In exercise of the powers vested in the Cabinet by section 5(9) of the Nauru Local Government Council Dissolution Act 1992, Cabinet hereby orders that all properties of the former Nauru Local Government Council shall vest in the Republic with immediate effect.

Upon the incorporation of Eigigu Holdings Corporation, the Republic transfers to Eigigu Holdings Corporation all the properties of the former Nauru Local Government Council with the exception of the Nauru Insurance Corporation, Nauru Development Fund, Nauru Royalty Fund and such other properties as the Republic may decide.

This Order may be cited as the Nauru Local Government Council Dissolution Order 1996.
