CONSTITUTION OF NAURU
ARTICLE 23
ASSIGNMENT OF RESPONSIBILITY FOR THE
BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I KENNAN ADEANG, M.P., PRESIDENT OF THE REPUBLIC OF NAURU, DO HEREBY, WITH IMMEDIATE EFFECT, ASSIGN TO THE MINISTERS NAMED BELOW, THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:-

MINISTERS OF CABINET

BUSINESS OF GOVERNMENT

HIS EXCELLENCY KENNAN ADEANG M.P.

THE RESPONSIBILITIES FOR THE PORTFOLIOS OF THE PRESIDENT, ISLAND DEVELOPMENT & INDUSTRY, CIVIL AVIATION AUTHORITY, EXTERNAL AFFAIRS, INTERNAL AFFAIRS AND THE PUBLIC SERVICE.

THE RESPONSIBILITIES FOR THE PORTFOLIO OF FINANCE AND ANY MATTERS AS MAY BE DELEGATED BY THE PRESIDENT UNDER THE PORTFOLIO OF MINISTER ASSISTING THE PRESIDENT.

THE HONOURABLE ANTHONY AUDOA M.P.

THE RESPONSIBILITY FOR THE PORTFOLIO OF JUSTICE.

THE HONOURABLE CLINTON BENJAMIN M.P.

THE RESPONSIBILITY FOR THE PORTFOLIO OF HEALTH.

THE HONOURABLE GODFREY THOMA M.P.

THE RESPONSIBILITY FOR THE PORTFOLIO OF INFRASTRUCTURE AND COMMUNITY SERVICES.

THE HONOURABLE REMY NAMADUK M.P.

THE RESPONSIBILITY FOR THE PORTFOLIO OF EDUCATION.

THE ABOVE ASSIGNMENT SHALL BE EFFECTIVE FROM 27TH NOVEMBER, 1996 UNTIL REVOKED OR VARIED, IN ACCORDANCE WITH ARTICLE 23 OF THE CONSTITUTION.
