#### **SUPREME COURT SESSIONS**

HIS HONOUR MR. JUSTICE HENRY BARRY CONNELL, CHIEF JUSTICE OF NAURU, SHALL PRESIDE OVER THE NEXT SUPREME COURT SESSION COMMENCING ON MONDAY,  $2^{\rm ND}$  JULY 2001.

ONLY CASES WHICH HAVE BEEN ADJOURNED IN THE LAST SITTINGS OF THE SUPREME COURT (MAY 2001) WILL BE DEALT WITH IN THIS SESSION.

THERE WILL BE ANOTHER SESSION OF THE SUPREME COURT ON 6-20 SEPTEMBER THIS YEAR. THE PARTIES OR THEIR LEGAL REPRESENTANTIVES WISHING TO AVAIL THEMSELVES OF THE OPPORTUNITY TO BRING ANY MATTERS OR CAUSES BEFORE THE SUPREME COURT ARE ADVISED TO MAKE AN APPLICATION REQUESTING FIXTURE OF THEIR CASES TO THE REGISTRAR OF THE SUPREME COURT 14 DAYS BEFORE THE COMMENCEMENT OF THE SESSION. FIXTURES WILL ONLY BE GIVEN UPON APPLICATION OF PARTY WHO MUST ADVISE THE REGISTRAR THAT THE CASE IS READY FOR TRIAL.
