**CUSTOMS (RATES OF DUTY) ACT 2010**

For the information of the public, the Department of Justice and Border Control wishes to advise that, from 1 July 2011, under section 7 of the Customs (Rates of Duty) Act 2010 the rates of duty on cigarettes, tobacco and alcohol will rise by 5%. The new rates of duty will be as follows:

- a) Cigarettes- \$110.25/1000 cigarettes
- b) Cigars and tobacco other than cigarettes- \$55.13/ 500g
- c) Spirits and pre-mixed drinks containing wine- \$4.20/ litre
- d) Beer- \$2.10/ litre
