**PUBLIC SERVICE SALARY DETERMINATION**

I, **HON. BARON DIVAVESI WAQA, M.P.**, President and Minister for the Public Service under Section 22(1) of the Public Service Act 1998.

- a) Revoke each instrument:
  - i. that fixes rates of salary under Section 22(1) of the Act; and

- b) Determine that the salary for each officer from time to time holding a position in the Public Service at a level and amount specified in the schedule.
