**RONWAN DATE REGULATIONS 2014**

SL No. 7 of 2014

Notified on 30 June 2014

Cabinet makes the following regulations under s. 6 of the *Ronwan Act 2013*.

**1. Citation**

These Regulations may be cited as the *Ronwan Date Regulations 2014*.

**2. Commencement**

These Regulations commence on the day they are notified.

**3. Interpretation**

In these Regulations:

- 3.1 'the Act' means the *Ronwan Act 2013*.
- 3.2 Words and expressions defined under the Act have the same meaning under these Regulations.

**4. List Certification Date**

- 4.1 Regulation 4. of the *Ronwan Regulations 2014* is hereby repealed.
- 4.2 The List Certification Date defined under ss. 3.7 of the Act, means 25 June 2014.

**5. Phosphate Land Dispute Notification Date**

- 5.1 Regulation 5. of the *Ronwan Regulations 2014* is hereby repealed.
- 5.2 The Phosphate Land Dispute Notification Date' defined under ss. 3.11 of the Act, means 9 July 2014.

**6. Primary Vesting Date**

The Primary Vesting Date defined under ss. 3.12 of the Act, means 9 June 2014.

**7. Final Vesting Date**

The date for disbursement and payment of monies held by the Trust pursuant to s. 23 of the Act shall be 15 September 2014.

**8. Date of Winding-Up of Fund 2 (s. 29)**

Fund 2 shall be deemed to be wound-up for all purposes on 30 September 2014.

**9. Date of Winding-Up of Fund 4 (s. 30)**

Fund 4 shall be deemed to be wound-up for all purposes on 30 September 2014.

**10. Date of Winding-Up of Fund 1 (s. 31)**

Fund 1 shall be deemed to be wound-up for all purposes on 30 September 2014.

**11. Date of Winding-Up of Fund 3 (s. 32)**

Fund 3 shall be deemed to be wound-up for all purposes on 30 September 2014.

**12. Date of Winding-Up of Nauru Royalty Fund (s. 33)**

The Nauru Royalty Fund shall be deemed to be wound-up for all purposes on 30 September 2014.

**13. Date of Winding-Up of Nauru Development Fund (s. 34)**

The Nauru Development Fund shall be deemed to be wound-up for all purposes on 30 September 2014.

**14. Dissolution of NPRT (s. 36)**

At 12:00 noon, local Nauru time, on 1 October 2014, Nauru Phosphate Royalties Trust shall dissolve and cease to exist as a body corporate.
