ARTICLE 21**

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT, HON. LIONEL ROUWEN AINGIMEA, M.P. BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE ON THE TWENTY-SIXTH DAY OF JULY 2024 UNTIL THE RETURN OF THE HIS EXCELLENCY THE PRESIDENT, HON. DAVID W.R. ADEANG, M.P.
