

ARMS, LIQUOR AND OPIUM PROHIBITION (PAPUA) ORDINANCE 1951.⁽¹⁾

No. 30 of 1951.

An Ordinance to amend the Arms, Liquor and Opium Prohibition Ordinance 1911-1950 of the Territory of Papua.

BE it ordained by the Administrator of the Government of the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the Papua and New Guinea Act 1949-1950, as follows:—

1.—(1.) *This Ordinance may be cited as the Arms, Liquor and Opium Prohibition (Papua) Ordinance 1951.*⁽¹⁾ *Short title and citation.*

(2.) *The Arms, Liquor and Opium Prohibition Ordinance 1911-1950⁽²⁾ of the Territory of Papua is in this Ordinance referred to as the Principal Ordinance.*

(3.) *The Principal Ordinance, as amended by this Ordinance, may be cited as the Arms, Liquor and Opium Prohibition Ordinance 1911-1951.*

2. *This Ordinance shall come into operation on a date to be fixed by the Administrator by notice in the Gazette.*⁽¹⁾ *Commencement.*

(a) The *Arms, Liquor and Opium Prohibition (Papua) Ordinance 1951* was not brought into operation before the date fixed under Section 35 of the *Papua and New Guinea Act 1949-1950*, and *semble*, is not continued in force by Section 56 of that Act.

PART B: NATIVES—

Definitions. 3. Section three of the Principal Ordinance is amended by omitting the definition of "native".

Employer's Arms Permit. 4. Section thirteen of the Principal Ordinance is amended by omitting from paragraph (a) of sub-section (1.) the words "within the meaning of the Ordinance Interpretation Ordinance, 1911-1933.⁽³⁾"

Explosives Permit. 5. Section thirteen A of the Principal Ordinance is amended—
(a) by omitting from sub-section (1.) the words "of European descent" and inserting in their stead the words "other than a native"; and
(b) by omitting from sub-section (2.) the words "of European descent" and inserting in their stead the words "not a native".

Permit to use liquor. 6. Section fifteen of the Principal Ordinance is repealed.

Schedule. 7. The Schedule to the Principal Ordinance is amended by omitting Form C.
