1).**

Schedule 1 of the Principal Act is amended by -


- (a) deleting in the heading of Table 2 the words "and onwards" and replacing them with the following:
"to 30 June 2012"; and
- (b) inserting a new Table 3 as follows:

"Table 3 - Rates of Tax for the period 1 July 2012 and onwards.

Column 1. Parts of Taxable Income.	Column 2. Percentage.
The part of the taxable income that -	
does not exceed K10,000.00	0
exceeds K10,000.00 but does not exceed K18,000.00	22
exceeds K18,000.00 but does not exceed K33,000.00	30
exceeds K33,000.00 but does not exceed K70,000.00	35
exceeds K70,000.00 but does not exceed K250,000.00	40
exceeds K250,000.00.	42


