MADE by the National Parliament and deemed to come into operation on 1 January 2008.

AMENDMENT OF SCHEDULE 1.

Schedule 1 of the Principal Act is amended by -

- (a) inserting in the heading of Part 2 the following new words after the number 2007 "to 31 December 2007"; and
- (b) inserting the following new Part:-

"PART 3. - SALARY AND WAGES WITHHOLDING TAX RATES.


