AN ACT

entitled

***Income Tax (Salary or Wages Tax)(Rates)(Amendment) Act 2022,***

Being an Act to amend the *Income Tax (Salary or Wages Tax)(Rates) Act 1979,*

MADE by the National Parliament and deemed to come into operation for the period 1 June 2022 to 31 December 2022 and then lapsing so then the former schedule come back into effect.

**AMENDMENT OF SCHEDULE 1.**

Schedule 1 of the Principal Act is amended -

(a) in the heading of Part 3 by inserting after the number "2018" the following:

"to 31 May 2022 and then from 1 January 2023"; and

(b) by inserting after Part 4 the following new Part:

**"PART 5. - SALARY AND WAGES WITHHOLDING TAX RATES  
APPLICABLE FROM 1 JUNE 2022 TO 31 DECEMBER 2022.**
