## PROCLAMATION

**A** Proclamation to delimit the offshore area.

WHEREAS by Section 2(5) of the *Petroleum (Submerged Lands) Act 1975*, it is provided that the High Commissioner in Council may from time to time by proclamation delimit the offshore area either in whole or in part:

AND WHEREAS it is desired that the area within the line of delimitation set out in the Schedule hereto be deemed to be part of the offshore area:

NOW THEREFORE, I, Thomas Kingston Critchley, High Commissioner, by virtue of the powers conferred by the said Section 2(5) of the said Act and all other powers me enabling, and having received the advice of the Executive Council, hereby proclaim and delimit the offshore area in accordance with the line of delimitation specified in the Schedule hereto, but to the extent only that that area includes—
