Organic Law on Provincial Government

CHARTER

GRANTING PROVINCIAL GOVERNMENT TO THE MILNE BAY PROVINCE

WHEREAS

(1) by notice published in the *National Gazette* on 12th May, 1977 the Minister responsible for provincial affairs (hereinafter called "the Minister") recognized, for the purposes of the Organic Law on Provincial Government (hereinafter called "the Organic Law") and of Section 187B of the National Constitution (grant of Provincial Government), a constituent assembly for the Milne Bay Province; and

(2) the Minister has, on behalf of the National Government, consulted with that constituent assembly on a constitution for the Province and on the granting of provincial government to the Province; and

(3) the National Parliament, by an absolute majority vote, on 4th November, 1977 on the motion of the Minister, resolved that the National Executive Council be authorized to approve the grant of provincial government, and the granting of a Charter under Section 6 of the Organic Law to the Milne Bay Province; and

(4) the provincial constituent assembly for the Milne Bay Province on 16th March, 1978 adopted, in accordance with Part III of the Organic Law, a constitution for the Milne Bay Province that is not inconsistent with the National Constitution or the Organic Law; and

(5) the National Executive Council has advised me to grant provincial government to the Milne Bay Province, NOW THEREFORE I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 6 of the Organic Law and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, by this Charter grant, in the name and on behalf of the Independent State of Papua New Guinea, provincial government to the Milne Bay Province.

Organic Law on Provincial Government

CHARTER

GRANTING PROVINCIAL GOVERNMENT TO THE SOUTHERN HIGHLANDS PROVINCE

WHEREAS

(1) immediately before the commencement of the Organic Law on Provincial Government (hereinafter called "the Organic Law") there was established a provincial government body in respect of the Southern Highlands Province; and

(2) by Section 109 of the Organic Law the National Parliament shall be deemed to have made a resolution under Section 4 of the Organic Law that the National Executive Council be authorized to approve the grant of provincial government, and the granting of a Charter under Section 6 of the Organic Law, to the Southern Highlands Province; and

(3) the provincial constituent assembly for the Southern Highlands Province on 14th December, 1977 adopted, in accordance with Part III of the Organic Law, a constitution for the Southern Highlands Province that is not inconsistent with the National Constitution or the Organic Law; and

(4) the National Executive Council has advised me to grant provincial government to the Southern Highlands Province,

NOW THEREFORE I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 6 of the Organic Law and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, by this Charter grant, in the name and on behalf of the Independent State of Papua New Guinea, provincial government to the Southern Highlands Province.

“With the exception of the functions of the Office of Environment and Conservation and the Wildlife Branch of the Department of Lands, Surveys and Environment, all the matters related to the functions of—”,

National Investment and Development Act 1974

NOTIFICATION OF APPROVAL OF REGISTRATION

IT is hereby notified in accordance with Section 54(12) of the *National Investment and Development Act 1974* that—

(a) under Sections 54(9) and 56(10) of the Act the Minister approved the registration of Motels of New Guinea Pty Limited (in this notification called “the Enterprise”) in respect of the following activities:

4. The Enterprise shall guide and assist Papua New Guinean enterprises in establishing businesses in activities ancillary to the registered activities.
5. The Enterprise shall use supplies and services available within Papua New Guinea, preferably provided by Papua New Guineans provided that such supplies and services are readily available at prices and of a quality similar to those obtainable from other sources.
6. Any application by the Enterprise to the Minister under any of these conditions shall be made in writing to NIDA.

3. The Enterprise shall keep all its books of account and other financial records in Papua New Guinea in the English language.

4. The Enterprise shall guide and assist Papua New Guinean enterprises in establishing businesses in activities ancillary to the registered activities.
